

# Technical Specifications Pikes Peak V2



## Product Scope & Intended Use

The Pikes Peak Press is intended to be used to extract fluid, such as oil, from organic material by means of heat and force without the use of solvents. This product is composed of two independently heat controlled platens, one fixed and one driven by a pneumatic cylinder for applying force. The organic material is placed inside a filter element and pressed between a collection barrier material such as parchment or PTFE sheets.




